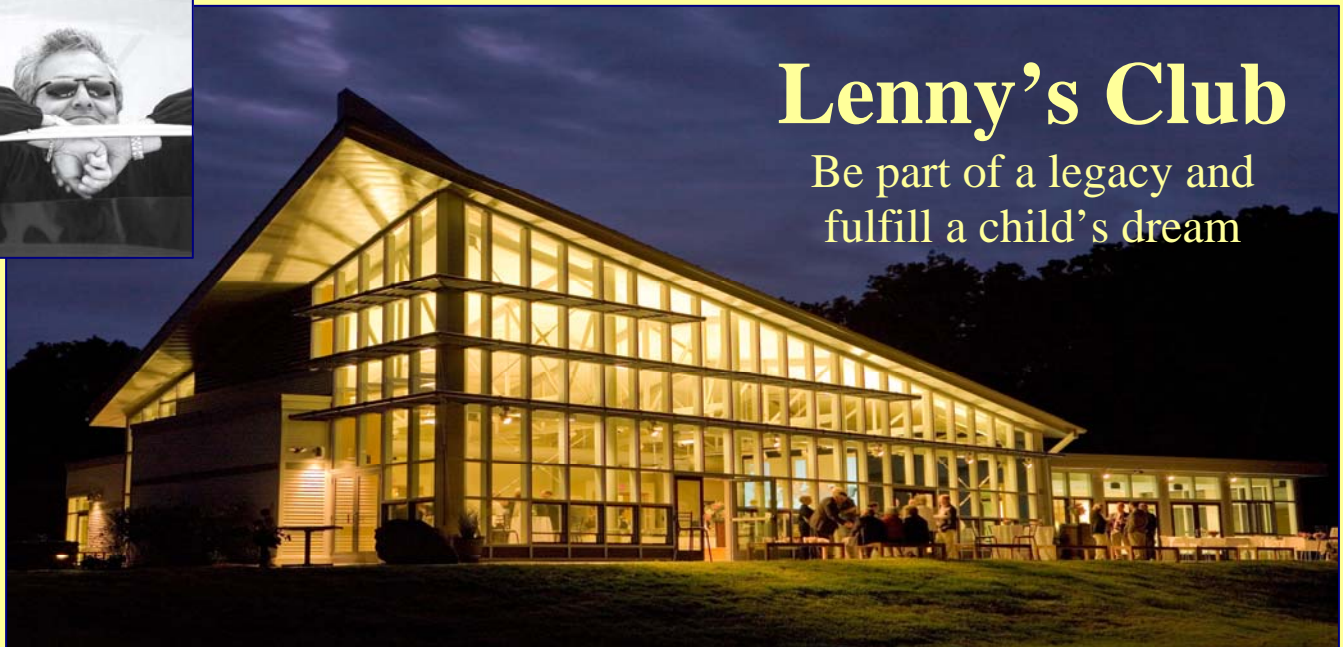




# Lenny's Club
